WELCOME ADDRESS BY THE EXECUTIVE VICE CHAIRMAN, NIGERIAN COMMUNICATIONS COMMISSION AT THE 2018 ANNUAL WORSHOP FOR JUDGES ON LEGAL ISSUES IN TELECOMMUNICATIONS HOLDING AT SHERATON HOTEL, LAGOS ON OCTOBER 2 – 5, 2018

Our hope through this comprehensive exercise is to explain AI, and demonstrate how AI already is altering the world and raising important questions for society, the economy, and how it affects the Courts.

My Lords, distinguished guests, ladies and gentlemen, the telecommunications industry has been identified as one of the key drivers to economic growth and development in the Nigerian polity. NCC however recognizes that no such reforms would stand the test of time without the foundation of due process and rule of law. That is the philosophy behind the bold step in exposing our judges to issues in telecommunications.

We thank our collaborator in this program – NJI for its role in ensuring the most conducive atmosphere for your Lordships to brainstorm and enhance professionalism and excellence.

Your Lordships, I encourage you to savour every resource made available to you at this Workshop. I also enjoin you to freely make contributions and raise issues that would assist the Commission in coming up with adequate regulatory measures that would enhance development in the communications sector. We assure you that every view expressed will be respected and considered.
