

Consultation Paper on the Review of the Licensing Regulations 2019

### Consultation Guidance

This Consultation Paper is a preliminary engagement of key stakeholders before the activation of the rule-making process of the Commission under Section 71 of the Nigerian Communications Act 2003. The outcome of this Consultation Process will provide the clarity and consensus that will support reviews and possible changes to the Licensing Regulations 2019. The Commission will take into account all comments and recommendations as part of its participatory approach to attainment of the objectives of the Nigerian Communications Act 2003.

#### 1. Introduction

The Licensing Regulations (Regulations) was first issued in 2019 and it provides for licences, application procedures and processes. The Regulations provides for both operational and frequency licences and their distinct procedures and requirements. More importantly the Regulations also set out procedures for transfer of licences, transfer of shares, surrender of licences as well as suspension and revocation of licences.

The Commission conducted a Regulatory Impact Assessment (RIA) on the implementation of the Licensing Regulations since its issuance in 2019 and also assessed its impact on the Nigerian Communications Sector. The outcome of the RIA sets out areas that will require changes and amendments and this can be illustrated in three key outcomes. First, sampled respondents within the Sector raised concerns on cumbersome nature of the licence application processes particularly as it relates to start ups and new entrants. Respondents are concerned that these universal requirements can constitute market barriers. Secondly, there are recommendations on the need to expand the licensing framework to accommodate new technologies and innovative services. Thirdly, some sampled licensees stated that the payment process for frequency licences is onerous and recommendations were made on possible instalment or alternative payment procedures.

## 2. Background

The Regulations provide a regulatory framework for the effective and efficient licensing processes and procedures in the communications industry for the operation of communications systems, facilities and services in Nigeria. It applies to individual licences, class licences and frequency licences as well as any other licence category as may be determined and published by the Commission.

## 3. Regulatory Proposals

These proposals form the baseline for the review and potential changes to the existing Licensing Regulations 2019 and provide both the context and regulatory purpose for these changes. The Commission puts forward five (5) regulatory proposals and the basis for each of them. These regulatory proposals provide broad outline of the proposed review and shows the foundational basis for the regulatory thought process. Therefore comments from stakeholders will help shape the specific changes and amendments that the Commission will put forward when it activates the rule making process in Q3 2025.

This Regulatory Proposal is to review the preliminary and pre-licensing evaluation process for frequency licences. The Proposal will also extend to licensing conditions and obligations for frequency licences.	The aim of this Regulatory Proposal is to provide clarity and certainty to the licensing process for frequency licences and set out well defined conditions and obligations for all frequency licensees. Lastly, this proposal will set clear milestones and timelines post frequency licensing and consequential regulatory actions.

This Regulatory Proposal is to set out clear expectations for privately owned and publicly listed licensees and provide unique obligations and requirements. The main aim of this Regulatory Proposal is to create a hover view of the ownership structure and possible changes in existing licensees of the Commission. It will also lead to the inclusion of well-defined provisions in the Licensing Regulations 2019 that takes into consideration the peculiarities of both privately owned and publicly listed licensees.

#### 4. Consultation Process

This Consultation process is for thirty (30) days from the date of its publication on the website of the Commission. The expected comments/feedbacks will guide the Commission in determining the specific areas for review and changes when it commences its rule making process as outlined by Section 71 of the Nigerian Communications Act 2003. The Process is open to licensees in the Nigerian Communications Sector, consumers, agencies of government, international agencies and Civil Society Organisations (CSOs).
