Your perspectives will ensure that the final document truly reflects national realities, regional priorities, and our shared vision for harmonised regulation, capacity development, investment promotion, and digital transformation in West Africa. I therefore invite and encourage robust, constructive, and frank discussions throughout the sessions.

Ask the challenging questions. Share your experiences. Offer your suggestions. It is through this collaborative refinement that we will forge a strategy that is truly fit for purpose: resilient, relevant, and capable of driving inclusive digital transformation for all our citizens while advancing economic and social development in the region.

I am confident that with your esteemed contributions, we will conclude this meeting with a comprehensive and actionable Strategic Plan that we can all be proud of; a Plan that will guide our collective efforts towards a more connected, prosperous, and digitally empowered West Africa.

Once again, I thank you for honouring this invitation and for your continued dedication to the WATRA vision.
